

PRIVACY NOTICE PURSUANT TO ARTICLE 13 OF REGULATION (EU) 2016/679

Robert Hollman Foundation provides the following information on the processing of personal data pursuant to Article 13 of Regulation (EU) 2016/679 that are collected through the completion of this form.

Data Controller

For the purposes of the GDPR (article 24) the Data Controller is: **FONDAZIONE ROBERT HOLLMAN, CF 84002280034 - Via Siena, 1 - 35143 Padova (Italy).**

Type of data processed

We collect and use personal data provided by you, the data subject (**your personal details, contact details, home institution or university**), to the extent that is needed and helpful to attain the purposes set out below.

Purpose of processing

- 1) Presentation of scientific and professional abstracts and publications within the 10th ICEVI Europe Conference from 15 to 17 May 2025.
- 2) Management of contact data to send you news, information, invitations, publications, announcements and newsletters regarding our Foundation's activities.

Legal basis for processing personal data

For the purpose 1) set out above, the legal basis of processing is identified in the legitimate interest of the data controller (Art. 6(1)(f)), represented by security reasons.

For the purpose 2) set out above, the legal basis of processing is the freely given consent you, the data subject, give to the processing of your personal data.

Data retention

We will keep personal data up to 18 months of consent. After this period, the data will be deleted or made anonymous, unless their further retention is necessary to fulfil legal obligations or to comply with orders from public authorities, or to protect a legitimate interest of the Foundation (defence in court).

In the case of consent to the processing of contact data for the purpose to send you news, information, invitations, publications, announcements and newsletters regarding our Foundation's activities, personal data shall be retained until the consent is revoked, unless their further retention

is necessary to fulfil legal obligations or to comply with orders from public authorities, or to protect a legitimate interest of the Foundation (defence in court).

Data Subject Rights

In relation to your personal data you can exercise your rights as data subject under the GDPR, namely:

- Right of access [article 15 of the GDPR];
- Right to rectification [article 16 of the GDPR];
- Right to erasure ('right to be forgotten') [article 17 of the GDPR];
- Right to restriction of processing [article 18 of the GDPR];
- Right to data portability [article 20 of the GDPR];
- Right to object [article 21 of the GDPR].

You have the right to withdraw your consent at any time.

Pursuant to article 19 of the GDPR, we shall communicate any rectification or erasure of personal data or restriction of processing requested by you, the data subject, to each recipient to whom your personal data has been disclosed, unless this proves impossible. You as data subject have also the right to lodge a complaint with the Italian Data Protection Authority (*Garante per la protezione dei dati personali*).

Necessary Data and Consent to data processing

Your data are necessary: otherwise, it is not possible for us to complete the registration of abstracts and your participation to ICEVI Europe Conference.

Moreover, we need your freely given consent to send you news, information, invitations, publications, announcements and newsletters regarding our Foundation's activities. Should you deny your consent, we will be unable to send you said communications.

Disclosure of data outside of the Foundation

We may disclose your personal data outside of our Foundation for various reasons. In particular, your personal data may be made available to entities providing IT system management on behalf of our Foundation, competent authorities and/or public bodies and supervisory authorities to comply with statutory requirements, other third parties collaborating with our Foundation for the Event and further communications regarding the ICEVI project (Comitato Scientifico della Decima Conferenza internazionale Icevi 2025; ICEVI Europe). Where appropriate, we shall formally appoint said third parties Data Processors pursuant to article 28 of the GDPR. Upon your request, you can access the detailed list of third parties to whom your personal data has been disclosed.

How data is processed

We process your personal data on paper or electronic form and enter your data into relevant databases that may be accessed – hence your data be disclosed to – our Foundation’s employees, contractors/consultants interns and other authorised individuals. Said employees, contractors/consultants interns and other authorised individuals may consult, use, process, compare the data as well as carry out any other appropriate action, including using automated means, always in compliance with statutory requirements that ensure, *inter alia*, protection of the confidentiality and security of the personal data, as well as data accuracy, update and appropriateness to the purposes for which the data is collected and used, as stated above.

Transfer of data outside of the EU

Your personal data may not be transferred outside of the EU.
